# Section 3 - Scope & Specifications

#### 1. <u>SCOPE OF WORK:</u>

1.1. Main scope of the project is to design a functional Stand for Maldives according to MMPRC's requirements (the "Stand"), and Construction of the Stand in accordance with the Regulations set by FITUR organisers (Refer to organiser's official website (<u>https://www.ifema.es/en/fitur</u>). It is the responsibility of the bidder to take all preventive measures set out by the fair organisers with regard to overall safety of the stand.

In addition, the scope of the works shall include;

- **1.1.1.** The construction of the Stand to agreed design proposal, and the construction of the Stand at the site provided to MMPRC by FITUR for the year 2024;
- **1.1.2.** Complete construction and handover of the finished stand 24 hours before the opening time of the fair, allowing sufficient time for MMPRC officials to arrange materials and finalise the stand. In addition, the stand should be cleaned, and garbage should be cleared from the stand area at the time of handing over the finished stand and it should be ready for immediate usage.
- **1.1.3.** The process of disassembling the stand should start as soon as the stand is handed over by MMPRC to the bidder at the end of the Fair. This should be carried out according to the organiser's guidelines.
- **1.2.** Interested parties need to submit a design and the estimated cost to construct the Maldives stand at FITUR 2024.
- **1.3.** The Stand concept and design should be presented in a contemporary design to attractively showcase the country's unique tourism product, whilst at the same time inspired by the element of luxury and usage of authentic Maldivian designs representing the unique features of the island destination. While proposing the design all regulations set out by the fair organisers.
- **1.4.** The stand should be accessibility friendly.

#### 2. The concept and design should strongly address the following points

2.1 Creativity and Attractiveness of the overall design.

- The proposed stand design should be thematically presented in a contemporary design using the latest interactive technologies in stand design without hindering any requirement set out in the RFP.
- The stand design should have a cohesive colour palette all throughout the design.
- The colours should take inspiration from the overall destination.
- 2.2 Photo wall A wall or prominent area of the Stand that can be used as a photo backdrop.
  - Should be a visually eye-catching backdrop which is "instagrammable". It should also be visible from outside and easily accessible to the visitors passing by (does not necessarily have to be placed at the back of the stand). Maldives branding should be visible in this area.
  - The purpose of this area is to attract visitors to Maldives Stand and take a picture and participate in the promotional and social media activities by sharing these pictures on social media.
- 2.3 Maldives branding (in Spanish Language) (Section 5) should be visible at prominent locations within the stand incorporated to the overall stand design.
- 2.4 Map of Maldives There should be a map of Maldives displayed at a prime location of the stand, visible to the visitors.
- 2.5 Space Utilisation All the requirements set forth in the Scope of Work should be fulfilled in an orderly, logically practical manner.
- 2.6 Consideration should be given to safety & preventive measures set out by the fair organiser.
- 2.7 The stand should be made in a way that prevents visitor bottlenecking in the stand.

## 3. STAND REQUIREMENTS

- Stand should have Co-exhibitor tables, storage and an information counter and should be arranged in a logical and practical manner considering the preventive and safety measures implemented by the fair organiser.
- The furniture and decorative items used should be simple and elegant to bring out the luxury image of the destination.
- The measurements given in specific areas should meet the criteria. Items with no specific measurements are left for the designer's choice. All furniture/equipment requirements are stated under each item.

- If the stand is elevated it should be identified in the proposed stand design. The height of the elevation should be mentioned in the proposal.
- 01 Wooden structures to separate the MMPRC meeting area and activity area and 02 wooden structures to separate the industry meeting area.
- Flooring with optic fibre lights, creating a pathway leading to the photo backdrop.
- 01 LED Wall (Size: 3 x5 ft) to display videos and photos.

#### 3.1. <u>Co-exhibitor Tables</u>

There should be a maximum number of designated semi-private meeting cubicles/areas for each co-exhibitor in the stand including the main exhibitor. Each area should have;

- 1 meeting table
- A seating arrangement for 4 people.
- Semiprivate partitions for privacy (not completely covered)
- co-branding space on the partition to display exhibitor name and graphics
- Universal electric plug points for each meeting table
- The chairs and tables should fit to the overall colour scheme and design used in the stand.
- Should include lockable drawers in each meeting table. Individual keys for each lock at the meeting table must be provided.
- Measurements and distance should be provided by the constructor within the proposal.

#### 3.2. Main Information Counter

- One information counter with shelves and lockable drawers to store promotional materials should be included in the design.
- The counter should have the capacity;
  - For 3 person
  - To display promotional materials and brochures
  - To display cultural items (dress; libaas and feyli jewellery fahtaru) for visitors to try and to take photos.
  - To display food items in the counter
  - Information counter can be presented in a creative design
  - Maldives logo (in Spanish) to be placed in front of the information counter.
  - Furniture: 03 comfortable stools for the representatives.

- Should include universal electric plug points.
- The design and colour scheme of the counter should fit/complement to the overall design of the stand.

## 3.3. Storage Room

- A lockable storage should be within the Stand to store promotional materials, should have enough space to accommodate boxes and hand carry trolley luggage.
- Should include a lockable cupboard to store valuable materials.
- Should include Racks to keep brochures, bags and other promotional materials. The racks should be able to hold an approximate weight of not less than 120kg.
- Should include universal electric plug points.
- Should include coat hangers/hooks for all exhibiting representatives (approximately 50+ pax)

## 3.4. Experience Zone

## 3.4.1. Main Scope of Experience zone

- Main scope of the project is to design an experience zone at the Maldives stand in FITUR to provide a peaceful and calming environment/centre for visitors that represents the destination's wellness and relaxation segment. The experience zone should depict an atmosphere that represents relaxation, stress relief, and emotional well-being.
- The experience zone concept and design should be presented in a contemporary design to attractively showcase the destination's wellness and relaxation segment, whilst at the same time inspired by the element of luxury and usage of authentic Maldivian designs, music/sounds representing the unique features of the island destination.

## 3.4.2. Design and Layout

- Provide an immersive experience to the visitors via projections of the visuals to the walls/flooring, audio of natural sounds and diffusion of natural scents.
- Design a semi closed and inviting layout that promotes relaxation and tranquillity. The experience zone should be placed at an accessible place in the stand.
- Incorporate elements such as;
  - Comfortable seating
    - $\succ$  2 to 3 chairs depending on the size of the area

- Soft & warm lighting
- 02 Electric sockets (for projector/diffuser/other requirements)
- Soothing colours (colour scheme of the centre should be colour coded, furniture, flooring as well as the walls.
- 1 Bluetooth speaker to play the audio.
- Projector- to project the video/visuals on the wall.
- Soothing smell (aromatic natural smells)
  - Should have 1-2 electric diffuser inside the centre depending on the size of the centre
- natural elements (e.g. plants native to Maldives such as small coconut palms) to create a calming natural atmosphere.
  - The plants to be arranged in a way that gives an aesthetically pleasing look to the stand.

## 3.5. Display & Rigging

- Installation of a curved LED Hanging screen , above the information counter facing the main aisle, which will serve as a dynamic element, showcasing our unique products and experiences, enhancing the overall aesthetic appeal of the stand.
  - Should be a standalone element which adds to the attractiveness of the stand.
  - Needs to be placed above the stand at the maximum height according to the guidelines by the fair organisers.
  - The orientation should be adjustable.
  - The LED Screen should be placed in a manner where it is visible and there is no obstruction to the visitor when viewing.
  - Should provide adequate sound.

the location of the co-exhibitor counters/B2B tables) digital promotional brochures and relevant information.

- The height of the kiosk should be at eye level. The display of the kiosk should be easily manageable and within reach.
- The kiosk should have an internet connection.
- The kiosk should have sufficient storage capacity to include our content.
- The display area should be adjustable.
- In addition to the above, relevant photos, decorative materials and equipment can be used in the design according to the overall theme to enhance the quality of the stand.
- Rigging structure with the Maldives logo visible from four sides of the stand. To have a hanging structure displaying a school of fish from the bottom of the rigging structure.

## 3.6. Stand Name

- Name of the Stand should be "Las Maldivas" with the logo (Section 5) which should be visible from all sides. Maximum visibility of the stand name should be provided.
- A hanging banner with the Maldives logo (As per Section 5) visible from all the sides of the stand needs to be placed above the stand at the maximum height.
- Maldives branding (As per Section 5) should be visible throughout the stand.

## 3.7. Lighting

- Adequate lighting should be provided all over the stand and should illuminate the stand well allowing to have ample lighting for photographs and videos.
- Harsh white fluorescent lighting should be avoided and instead use warm lighting throughout the stand.

## 3.8. <u>Meeting Area</u>

#### 3.9. Additional Services

- Should provide daily cleaning and garbage disposal services for the fair duration.
- Touched surfaces of the stand should be regularly cleaned during the fair days.
- Should provide hand sanitizers at the stand.
- A focal point should be present during the fair times to assist with any issues that may arise.
- Should have a first aid box placed in the storage area.

#### 4. ADDITIONAL CONDITIONS AND REQUIREMENTS

- **4.1.** The design should be in conformity to the Maldives Stand concept and Design Requirement and Stand Building Regulations set by FITUR 2024 Fair organisers (Refer to organiser's official website).
- **4.2.** It is the duty of the Selected Party to meet specific requirements of the FITUR 2024, so that the Stand receives due recognition from the organiser and public.

- **4.9.** Additional covid-19 protection gears at the stand.








## Section 6 - FLOOR PLAN













# A. B2B Meeting table area
